# SOLICITATION TO FILL COMMUNITY VACANCIES ON THE LOS ANGELES WORLD AIRPORT'S (LAWA) DISABILITY ACCESS and ACCOMMODATION ADVISIORY COMMITTEE (DAAAC)

The City of Los Angeles Commission on Disability (COD), is soliciting applications to fill two vacant positions on Los Angeles World Airports Disability Access and Accommodation Advisory Committee (DAAAC). Candidates must live in an are a served by Los Angeles World Airports. These areas include Los Angeles County, Orange County, San Bernardino County, Riverside County and Ventura County.

In order to balance the membership of the committee, the ideal candidate should have a vision, mobility, hearing; cognitive disability or works with people who have cognitive disabilities, vision loss, hearing loss or persons with mobility issues. The candidate should be an experience air travel who uses Los Angeles International Airport (LAX).

The Committee assists Airport Management in identifying barriers to travel, and recommends ways to address the needs of the traveling public with disabilities. Committee members serve as eyes and ears of the disability community in helping make our airports more accessible and user friendly. Committee members also serve as a catalyst for informing the disabilities community of initiatives LAWA is taking to serve them better.

Service on the Committee is voluntary and there is no monetary compensation for this service. Meetings are held on the third Wednesday of each month from 1:00 p.m. – 3:00 p.m., at the Flight Path Museum, 6661 West Imperial Highway, Los Angeles, CA., (at the end of the 105 Freeway). Access Services does provide rides to qualified persons with disabilities to the meeting site. Occasional field trips may occur. Los Angeles World Airports will provide transportation for field trips.

#### **Committee Composition:**

Six members from the Community (appointed by the Commission on Disabilities)
One Airline Representative (appointed by the Airlines)
Two Airport Representatives (appointed by LAWA)
One TSA Representative
Total composition of the Committee is 11 members.

#### **Qualifications:**

The Committee member should have a keen understanding of the barriers faced by travelers with various disabilities. The successful candidate must be committed to attending one meeting lasting two hours per month. There may be occasion where Committee members may be asked to participate in special events or special meetings.

Applicants must be able to travel to Los Angeles International Airport for meetings.
