## Employee Parking

Since March, LAWA has been working with ABM Parking Services to determine the best solution to transport all LAX employees parking in the remote lots while practicing social distancing (in 2019, ABM transported an average of 12,000 employees each day between the CTA and the remote lots). Near the end of March, LAWA issued over 8,000 access cards and parking permits allowing LAX employees temporary access to the CTA garages and Park One.

Effective April 20, both remote Lot East and Lot West closed. Employees now have access to P1, P4, P5, P6, and P7.

Effective April 23, Lot South also closed. Employees who park in Lot South have access to garages

P1, P3, P4, P5, P6, and P7. The Lot South shuttle will continue to serve the LAX Metro Bus Station.

Monthly payment accounts must be in good standing to take advantage of the temporary CTA parking.

Any employee who remains parked in any of the remote lots (after the closure) will be transported to their respective lot.

## Economy Lot E

Effective March 30, Economy Lot E stopped accepting new customers. The Lot E shuttle continued to return customers to the lot until April 30 when Economy Lot E closed until further notice.

Parking will continue to be available in the CTA garages (max. \$40/day) and at private parking locations. You can find a list of private parking options at LAX [here](#).

### Metro Green Line /

### LAX Metro Bus Station

For LAX employees who use the Metro Green Line at Aviation Station and the LAX Metro Bus station, LAX shuttle service will continue to operate at current service levels.

Additionally, social distancing is observed in the LAX shuttles and face coverings are required, per the Los Angeles County and City of Los Angeles health guidelines.

## LAX and Employee Shuttles

For your health and safety, we are following the guidelines listed below to slow the spread of Covid-19:

Passenger loads are limited to 15 passengers (including the driver) on the Airline Connection and LAX Employee Shuttles.

Entry onto the shuttles is required from the rear doors.

Non-medical face coverings are required on all LAX shuttles.

Disinfecting and cleaning of the LAX Shuttle fleet at a minimum of 3 times per day.
