Central Terminal Area (CTA) Parking



CTA Parking Structure 4 is undergoing facility enhancements for the Landside Access Modernization Program (LAMP) from January 15, 2018-June 30, 2018.

We recommend LAX employees and patrons use the Parking Structure 3 entrance to gain access to Parking Structure 4, Levels 3-4 since ramps 3-5 will be under construction.

LAWA Parking Services and ABM CTA Parking (not employee parking) will be relocated to trailer offices as a result of the LAMP enabling projects.

LAWA and ABM have been assigned to Trailers #2 & #3. These are located across Terminal 6 and were formerly Delta offices prior to the airline shuffle.

Employee Lots & Shuttle Service



Lot South / Lot C Relocation

Lot South parkers will be relocated to the northern end of Lot C on March 1, 2018 to make way for the LAMP project. Employees will be notified via flyers and email blasts.

New Employee Lot South has approximately up to 1,600+ spaces available for parking. A shuttle route will be implemented for the new Employee Lot South.

Beginning March 1, 2018, employees using the LAX remote employee parking lots (Lot A, AF#8, ICC, IT, and RV parking lot) may purchase hang tags online via the ABM website. Please be on the lookout for updates in the coming weeks for more details regarding online sales.

Shuttle Route Changes

The Tom Bradley International Terminal (TBIT) shuttle stop will be closed from 1:30 AM - 7 AM due to construction this coming February.

Passengers departing from TBIT during this time period must wait under the green sign entitled, "Flyaway, Buses, and Long Distance Vans" on the Arrivals/Lower level.

G Shuttle

Metro LAX/Aviation station will be closed due to construction on the Crenshaw/LAX Metro line from January 26, 2018-April 7, 2018.

Passengers will have to use the Hawthorne/Lennox Metro station during construction.

Three additional G Shuttles will join the fleet to maintain service levels. TAP verification will be enforced.
