## CTA PARKING

### Employee Parking Pass (EPP) Program

Effective January 1, 2019, monthly parking rates for EPPs will be increased. Please note that the purchase of EPP cards are exclusive to airlines only. Basic EPPs will be increased from \$200 to \$240 per month. Since P5 and P6 are high demand garages, Basic EPPs will no longer have access to these structures.

Premium EPPs will be increased from \$400 to \$480 per month. The purchase of EPP cards are exclusive to airlines only.

### Public Parking Rates

Effective January 1, 2019, CTA Parking structure rates will be updated to the following: 15 minutes free parking, \$5 the first hour or fraction thereof, \$4 each 30 minutes after the first hour, \$40 maximum for each 24 hour period.

**Facility Improvements**  
Parking Structures 3, 4, and 7 are expected to undergo facility enhancements due to the LAMP project. The Parking Access & Revenue Control System (PARCS) will be upgraded to an automated payment environment during the first half of 2019.

## EMPLOYEE LOTS

Effective February 1, 2019, monthly parking rates for Employee Lot East, West, South, and the Remote Auxiliary Lots (Imperial Cargo Complex, Imperial Terminal, Air Freight, and Lot A) will increase from \$55 to \$60 per month.

## VAN NUYS FLYAWAY

Effective January 1, 2019 the parking rates will be updated to the following: \$1 per hour, and up to \$5 maximum per day.

## G SHUTTLE

### Rail Service Suspension

Green Line rail service will be suspended between Hawthorne/ Lennox Station and Redondo Beach Station from January 04, 2019 at 9 PM through January 20, 2019 at 3 AM for the Crenshaw/LAX Transit Project. A free bus shuttle will be provided.

Passengers traveling to LAX should board the free Green Line replacement bus shuttle service (Line 853) at Crenshaw Station en route to Aviation/LAX station. The LAX G Shuttle will remain at its usual stop at Aviation/LAX Station.
